Payment of Fees

All fees and charges are payable by the first day of each term. Fees are non-refundable and are not subject to pro-rata payment. Any parent facing difficulties with the payment of fees should contact the Accounts Office.

School fees may be paid by:

- Weekly/ fortnightly/ monthly direct payments
- Credit card (MasterCard/ Visa). A credit card charge may apply for credit card payments.

A direct debt form is attached for your completion. Please complete the form and return it to accounts@tasg.nsw.edu.au by **10th December 2018**. The first fortnightly direct debt will commence on the 14th December 2018 and will conclude at the end of 29th November 2019.

If your account has insufficient funds when the automatic payment is due, please contact the school office **at least two days before** the due date to discuss the payment.

Payment Authority Plans will remain in place for the following year(s) unless advice is received from families before the start of the new School year. The School reserves the right to charge GST on all taxable supplies.

Overdue Fees

Fees are considered to be overdue when your payment is late. If you have a regular payment plan in place, your fees are overdue if you miss a payment or your payment is rejected by the bank. Term payments not made until later in the term are considered to be overdue.

If your payment will be late for any reason or you are falling behind, please contact Dilan Samuel (Accounts Officer) at the school, at the first sign of difficulty to discuss your circumstances and suitable payment options. To avoid being charged a \$50 administration levy, it is imperative that you communicate with the school. If you do not let us know what is happening, we cannot be of assistance.

Notice of Withdrawal of a Student

A term's notice of intention to withdraw a student from the School must be given in writing to the Principal, otherwise a full term's fees will be charged in lieu of notice.

A term's notice must also be given in writing to the Principal of intention to withdraw a student from the School for a limited period of one term or more. A term's fees will be charged in lieu of notice. Re-entry to the School after absence of more than one term is dependent upon a place being available. Due fees apply for absences of less than one term.
